## Assessment #1: Content Knowledge (Data from Licensure Tests of Content Knowledge

#### a. Brief description of the assessment and its use in the program

This is the state licensure examination that assesses content knowledge in six subfields of social studies. The assessment is the Praxis II, code 5081. Per state requirements, this assessment is taken before TC begin their Clinical 2 experience, which means that most take the test in the spring of their junior years. Students who fail take it again in their senior year.

### b. Alignment with NCSS Standards

This assessment aligns to Standards 1a, 1b, and 1c as the Praxis assesses the social science disciplines and content knowledge, disciplinary inquiry, and disciplinary forms of representation.

### c. Brief analysis of data findings.

Note that ETS no longer aggregates Praxis data based on the various subsections. This was confirmed in an email to our department that was received in June, 2019. The national and state averages below are the last samples for which the College has data, which date to 2012. These data are admittedly old, but it is included here to provide a basis of comparison with the three samples that are included above. Out of 36 test takers in the sample, 9 failed the test the first time taking it, for a failure rate of 25%. The high standard deviations suggest a wide range of scores, and the Spring 2018 group performed somewhat poorly on the test, with four of nine (44%) students failing. In the Fall, 2018 group, however, only two students failed, for a rate of 14%. If the data below hold any validity it suggests that the three cohorts are in line with state averages on all the subsections, above the national averages on the history sections, but weaker in the other social science categories. For examples, the national average in government was 66% correct, but only 61% for TC at our institution. There are similar variances in geography, economics, and behavioral science.

#### d. Interpretation for how data provide evidence for meeting standard components.

Data suggests that TC performance on this task is in line with national averages, as the national pass rate on the 2016-2017 Praxis was 75.86 and for the 2017-2018 Praxis was 73.08. This corresponds to the 75% pass rate in the data sets included above. Overall the pass rate for three years of test takers was 76.9% (see Figure 4). Overall TC are performing well in the history

subsections, adequately in the other social science areas, although weaker in behavioral sciences when compared to national averages.
